Mr. Morris moved to authorize Mrs. Whitlock and Mrs. Mitchell to sign agreements for alternative services and private residential school placements. Mrs. Elliott seconded and the vote was unanimous.

Mrs. Whitlock gave a budget review and explained the budget, the budget calendar and where we were at in the process.

Mr. McGraw moved to approve the Education and Operations Fund Resolution. Mrs. Elliott seconded and the vote was unanimous.

Education and Operations Fund Resolution

WHEREAS, the Board of School Trustees is the governing body of the Clinton Prairie School Corporation, Clinton County, Indiana, and

WHEREAS, HB 1009 requires the governing body of each school corporation to establish an education fund for the payment of expenses allocated to student instruction and learning under IC 20-42.5, and

WHEREAS, HB 1009 requires the governing body of each school corporation to establish an operations fund for the payment of expenses that are not allocated to student instruction and learning under IC 20-42.5;

THEREFORE BE IT RESOLVED, that the Board of School Trustees authorizes the Treasurer of the Clinton Prairie School Corporation to establish the education fund and the operations fund effective January 1, 2019.

Mrs. Whitlock spoke on current enrollment numbers for the Jr./Sr. High and Elementary schools.
